EXECUTIVE REPORT

We are delighted to present the 2025 Bowls New Zealand Annual Report to the bowls community and interested stakeholders. Over the past year, the sport of bowls in New Zealand has achieved remarkable growth, with notable progress in participation, membership, digital and facility investment.

Bowling Clubs – Membership and Participation

Every year Bowls NZ produces a detailed survey on how clubs are performing. This survey (census) has been running since 2010, so we have a wealth of information at club, regional and national level.

What is now evidential, is the changing delivery model for how our clubs engage with local communities. The 20th century saw bowls as a competitive sport for the weekend sports person. The 21st century evidences the evolution of the social bowler, and casual participant within bowling clubs.

The chart/data to the right shows the full playing (weekend/serious) membership declining since 2010 from 33,000 to 21,000 – a trend consistent with many sports in Aotearoa.

However, when you add in the Limited and Twilight membership categories (social membership), we can evidence growth from 33,000 (2010) to 43,000 (2024) in bowling club membership.

A similar story exists for casual participation. 51,114 casual bowls participants in 2010 versus 126,889 in 2024.

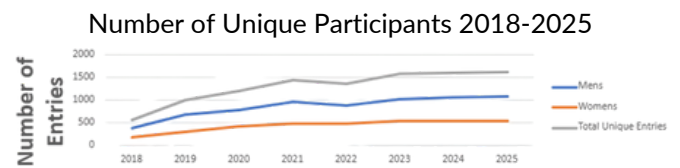
The participation numbers for our rangatahi and tamariki (our youth) is the result of dedicated individuals and clubs, volunteering their time and energy. In 2024, 16,782 youth had a bowls experience (up from 9,901 in 2023). This growth is largely driven by initiatives that deliver bowls in schools, often utilising artificial sports surfaces and halls to introduce the game to younger generations.

The challenge for Bowls New Zealand in the coming years is not-so-much to continue this trend towards social membership/bowls (that horse has already bolted) but instead we need to tell our stakeholders (including our own clubs) that this change is happening, and it's positive.

National Events

National bowls events were held in various regions, including Dunedin, Canterbury, Wellington, Waikato, Hawkes Bay, and Auckland. The Summerset Nationals (Singles, Pairs and Fours) enticed over 1600 entrants in January and February 2025. When compared to the world largest bowls event (the Australian Open) at 4000 entrants, our 1600+ compares quite favourably.



This data shows a sport and community (bowls) that is quickly changing its community delivery model to meet the 21st century Kiwi who wants to play sport when they want, in a shortened format and as a social engagement tool.

National Interclub and Intercentre events evidence widespread participation, with 24 of 27 centres involved. Champion of Champion events also maintained strong engagement, with an average of 22 centres sending representatives. Future considerations including zone playoffs, will need to be discussed as costs (especially flights) become a barrier to participation.

International Achievements

The international highlights for 2024/2025 were the hosting of the 2024 Oceania Championships, the 2024 World Champion of Champion Singles and the 2025 Trans-Tasman. Thanks to Royal Oak Bowls, New Lynn Bowling Club, Browns Bay Bowling Club and the Naenae Bowling Club for your support.

An 'off the green' highlight in 2025, was confirmation that bowls would remain in the 2026 Commonwealth Games. Having been an historic and founding Commonwealth sport, it would have been disappointing to not return in 2026. Perhaps though, underscoring the changing face of international bowls, is that both the 2025 World Cup in November and the 2026 Commonwealth Games will be played indoors as short format 'sets' bowls.

Operational Highlights

BowlsHub, our database and competition management system, continues to expand, now serving 16 centres with 9,000 members. Bowls+ was added to the BowlsHub platform in March of 2025, and presents as a grading and performance tool for the competitive bowler. Whilst Bowls+ is not for all bowlers, we have no doubt that as we roll out future versions, Bowls+ will be an important aspect of the bowls experience for many of our members.

The digital (technology) world continues to surprise. Who would have thought five years ago, Bowls New Zealand would be producing 'in-house' 30+ days of Bowls for Sky Sport, plus another 50+ days for the YouTube platform. Over the past few months, we have also been working with companies assessing the latest AI tools and how they can reshape the digital experience for our members.

The number of certified umpires and coaches continues to grow, testament to the willingness of our community to volunteer their time in support of our games and clubs.

The transition to carpet greens has also continued, with 27.5% of greens now artificial, and that is not counting the 100+ artificial greens that exist within Retirement Villages. The other facility change is the increasing number of canopy style covers appearing over our greens. At last count there are 11 clubs who are currently engaged in the design and feasibility of a covered green.



Bowls New Zealand maintains its financial stability, with \$1 million in reserves. An operating surplus of \$1837 was well within the Board-approved budget. Additional expenditure reflects intentional investment in Broadcast, BowlsHub, Bowls+ and Twilight Bowls.

Strong partnerships with organisations such as Summerset Retirement Villages, Howden Group, Dynasty, Prebble Seeds, Game On Turf, Shade Systems, Aero, and Tower, along with support from community groups like NZCT, Lion Foundation, AGT, Foundation North, Four Winds, and Pub Charity, have contributed significantly to the sport’s development. Support (both financial and non-financial) from Sport New Zealand and HPSNZ has also been crucial for growth and success.

Thanks to the dedication of club officials, volunteers, and supporters, the sport of bowls continues to thrive across the country. The Bowls NZ team remain focused on supporting the wider bowls community and building on the successes, as we look to the future.

PRESIDENT'S REPORT

Piripi Huwyler



Tēnā koutou katoa,

As the second year of my three-year term as Bowls New Zealand President draws to a close, I take great pleasure in reflecting on my activities and sharing my thoughts on the significant progress made by Bowls New Zealand, and the outstanding success of some of our players during the 2024–25 season.

Over the past twelve months there have been some surprise results and remarkable achievements from within our bowls communities, particularly on the international stage.

It all began with the Auckland based Tokelau men's pair of Pale Luka and Peni Panapa securing an emotional Oceania gold medal last November, competing against a field that included the 2024 Australian Open pairs champions, Jack McShane, and fellow teenager Joey Clarke. Just a week later, Auckland based Tongan international Millie Nathan continued her stellar form at the Oceania Challenge, winning the World Women's Champion of Champions singles gold medal in atrocious weather conditions at the Browns Bay Bowling Club.

Then as 2025 commenced, relatively unknown Auckland bowler Matt Berry captured the Summerset National Men's Singles title, marking a significant milestone in his career. At the historic Rangiora Bowling Club, I also witnessed an extraordinary performance by Dunedin's young McEwan brothers, Lachie (10) and Jordan (12), who, alongside their father Brent, advanced to the last thirty-two of the Summerset National Fours.

Their accomplishment not only demonstrated their immense talent but also highlighted the promising future those two young boys have within our sport.

Another key highlight for me was the successful defence of the para trophy by the Blackjacks para team in what was another closely contested battle during this year's Trans-Tasman series in Naenae. Our Blackjacks open women were equally impressive, narrowly missing victory due to points differential. Although our Blackjacks open men and both development teams fought valiantly throughout the competition, the strength and depth of the Australian squads proved too much on this occasion. This year's Trans-Tasman also marked the retirement of one of Bowls New Zealand's most distinguished players, Val Smith. Val's contribution to the sport as an international player will be deeply missed, and I extend our utmost gratitude for her many years of dedication to Bowls New Zealand.

Undoubtedly, the standout performances this year have been those of Blackjack Selina Goddard. Selina's ability to devote more time to playing in Australia has clearly been a pivotal factor in her success. Her remarkable run at the 2025 Victorian Open, where she claimed all three major titles, her contribution to Cabramatta securing the New South Wales State Pennant, and her triumph at the Australian Open women's pairs alongside Chloe Stewart are a testament to her exceptional skill and perseverance. Selina's accomplishments this year are a source of pride not only for her whānau and sponsors but also for all of us in New Zealand.

Entering the final year of my term as President, I am dedicated to increasing my involvement with clubs across the various centres, which this year saw me attend tournaments hosted by the Turangi, Manaia and Raumati Bowling Clubs. By actively participating in and supporting such events, I aim to showcase and celebrate the immense contributions those tournaments and clubs make to our sport. Through this involvement, I have already observed how clubs are embracing Bowls New Zealand's vision by transitioning into vibrant community hubs where local networks are strengthened, diverse groups come together and community-focused activities flourish, ensuring those clubs and bowls remain relevant and thriving.

On December 14th, Julie Blake and I had the pleasure of attending the Claudelands Bowling Club centenary celebration in Hamilton, and on May 17th, Bowls Auckland President Helen Blick and I were honoured guests at the Maraetai Bowling Club for the opening of their new synthetic green. A special thank you to both clubs for their generous hospitality, and to Maraetai Bowling Club Vice President, Ross Peden who graciously hosted me at his home.

Looking ahead, I am excited about attending the 2026 Commonwealth Games in Glasgow. After uncertainties surrounding its future, the confirmation of this event brings reassurance and renewed optimism for our sport. The Commonwealth Games has long been considered the pinnacle international event for bowls offering our Blackjacks the chance to compete at the highest level internationally. With bowls secured as a sport for at least the 2030 Commonwealth Games, the event will continue to serve as a powerful incentive for our players to aspire to earn their place on this prestigious stage.

Congratulations to Brett O'Riley on his appointment as the World Bowls President and for his and World Bowls role in securing the inclusion of bowls in next year's Commonwealth Games.

In my capacity as a Director of Bowls New Zealand and International Bowls for the Disabled (IBD), I have had the opportunity to work with Brett and CEO Neil Dalrymple and understand the wealth of experience and expertise they both bring to advance our sport globally. From their work, World Bowls is now close to formalising a partnership agreement with the IBD and achieving International Paralympic Committee (IPC) membership, a significant milestone, which will establish a clear pathway toward eventual inclusion of bowls in the Paralympics and ultimately, summer Olympic Games.

Under the leadership of CEO Mark Cameron and his exceptional team, Bowls New Zealand this season delivered highly successful, national, and international events, including the National Inter-Centre, Inter-Club, Opens, Champion of Championship finals, the Oceania Challenge, and the Trans-Tasman Test Series. Alongside those successes, Mark and his team introduced a range of strategic and marketing initiatives aimed at growing the game at grassroots level and deepening community engagement, particularly among Rangatahi and social bowlers. Programmes targeting youth development, support for social bowls, and the introduction of digital tools like Bowls+ are helping connect bowls with a broader and more diverse audience.

The recent appointment of Iain Laxon to drive the Bowls+ platform further reflects Mark's vision and approach to innovation, which will create a more inclusive, modern future for the sport.

I would also like to acknowledge the outstanding leadership of our board and new chair, Mark O'Connor, whose collaborative approach, and support of CEO Mark Cameron has been instrumental in guiding Bowls New Zealand through another successful year. With a strong mix of corporate, business, and administrative expertise, the board continues to provide balanced, strategic leadership and governance that supports the sport's growth and long-term success across all levels of the game.

Sadly, this year we bid farewell to Ann Wright from the board. A respected past president and committed board member, her contribution, wisdom, and leadership has helped shape the direction of Bowls New Zealand during her tenure. Ann will be dearly missed by us all and on behalf of Bowls New Zealand, I extend our heartfelt thanks to Ann for her remarkable service and wish her all the best as she settles back into a well-deserved retirement.

Most importantly, the success of Bowls New Zealand and our events would not be possible without our sponsors, the support of our bowls communities, and the tireless efforts of all the volunteers, supporters, umpires, bowling clubs and greenkeepers.

Opinion

We have audited the special purpose financial statements of Bowls New Zealand Incorporated, which comprise:

- the statement of financial position as at 30 June 2025;
- the statement of comprehensive revenue and expense for the year then ended;
- the statement of changes in net assets/equity for the year then ended; and
- the statement of accounting policies and notes to the special purpose financial statements.

In our opinion, the special purpose financial statements on pages 21 to 30 present fairly, in all material respects, the financial position of Bowls New Zealand Incorporated as at 30 June 2025, and its financial performance for the year then ended in accordance with the stated special purpose accounting policies.

Basis for opinion

We conducted our audit in accordance with International Standards on Auditing (New Zealand) (ISAs (NZ)). Our responsibilities under those standards are further described in the **Auditor's responsibilities for the audit of the financial statements** section of our report.



1.STATEMENT OF ACCOUNTING POLICIES

BASIS OF PREPARATION

The reporting entity is Bowls New Zealand Incorporated ("Bowls NZ"). Bowls NZ is domiciled in New Zealand and is an incorporated society registered under the Incorporated Societies Act 1908. Bowls NZ as an incorporated society is not required to report under the Public Benefit Entity International Public Sector Accounting Standards ("PBE IPSAS") and other applicable financial reporting standards as appropriate that have been authorised for use by the External Reporting Board for Not-For-Profit entities. However, it has chosen to voluntarily adopt the majority of these standards in the preparation of these special purpose financial statements as it transitions towards full implementation, with the exception of the non-presentation of a cashflow statement and key management personnel disclosures, as well as a Statement Of Service Performance.

The significant accounting policies used in the preparation of these financial statements are set out below. These financial statements have been prepared on the basis of historical cost, as modified by the fair value measurement of non-derivative financial instruments, and on a going concern basis.

The board considers that the accounting policies adopted in these special purpose financial statements are appropriate to give the users of the financial statements meaningful information about the performance and position of the organisation for the current year.

SIGNIFICANT ACCOUNTING POLICES

There have been no changes in accounting policies from the year prior.

(a). Revenue

Revenue is recognised to the extent that it is probable that the economic benefit will flow to Bowls NZ and revenue can be reliably measured. Revenue is measured at the fair value of the consideration received or receivable. The following specific recognition criteria must be met before revenue is recognised.

Revenue from non-exchange transactions

Donations

Donations are recognised as revenue upon receipt and include donations from the general public or donations received for specific programmes. In kind services, including volunteer time are not recorded as revenue or expense.

Grant revenue

Grant revenue includes grants given by charitable organisations, philanthropic organisations and businesses. Grant revenue is recognised when received unless there is a clear use or return condition. In this case, revenue is recognised when the conditions attached to the grant has been complied with. Where there are unfulfilled conditions attaching to the grant, the amount relating to the unfulfilled condition is recognised as a liability and released to revenue as the conditions are fulfilled.

Revenue from exchange transactions

Sponsorship income

Funds received from sponsors are recognised as revenue when the terms of the relevant sponsorship agreement have been met.

Membership fees

Annual fees and subscriptions from bowls clubs are recognised in revenue evenly over the membership period.

Event income

Entrance fees for functions and events are deferred initially and recorded as revenue when the function or event takes place. Related expenses are recognised as prepayments until the events occur.

Interest and dividend income

Interest revenue is recognised as it accrues, using the effective interest method. Dividend income is recognised when the dividend is declared.

Sale of Goods

Revenue from sale of goods is recognised in profit or loss when control has been transferred to the buyer.

(b). Financial Instruments

Financial assets and financial liabilities are recognised when Bowls NZ becomes a party to the contractual provisions of the financial instrument.

Bowls NZ derecognises a financial asset or, where applicable, a part of a financial asset or part of a group of similar financial assets when the rights to receive cash flows from the asset have expired or are waived, or Bowls NZ has transferred its rights to receive cash flows from the asset or has assumed an obligation to pay the received cash flows in full without material delay to a third party; and either:

- Bowls NZ has transferred substantially all the risks and rewards of the asset; or
- Bowls NZ has neither transferred nor retained substantially all the risks and rewards of the asset but has transferred control of the asset.

Financial assets

Financial assets within the scope of PBE IPSAS 41 Financial Instruments: The classifications of the financial assets are determined at initial recognition.

Financial assets at Amortised Cost

Bowls NZ's financial assets recorded at amortised cost include: cash and cash equivalents, short-term investments, receivables from non-exchange transactions.

Financial assets at fair value through surplus or deficit

Bowls NZ's funds invested in and managed by Jarden Investments fall into this category. These financial instruments are recognised at fair value at balance date. Changes in fair value are recognised through surplus or deficit each year.

Impairment of financial assets

Bowls NZ assesses at the end of reporting date whether there is objective evidence that a financial asset or a group of financial assets is impaired. Different criteria to determine impairment are applied for each category of financial assets. Where an impairment is identified, the carrying amount of the asset is reduced and the loss is recognised in the surplus or deficit for the reporting period.

Financial liabilities

Bowls NZ's financial liabilities include trade and other payables (excluding GST and PAYE).

All financial liabilities are initially recognised at fair value (plus transaction cost for financial liabilities not at fair value through surplus or deficit) and are measured subsequently at amortised cost using the effective interest method.

(c). Cash and cash equivalents

Cash and cash equivalents are short term, highly liquid investments that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value.

(d). Short term investments

Short term investments comprise term deposits which have a term of greater than three months and less than 12 months and therefore do not fall into the category of cash and cash equivalents.

(e). Inventories

Inventories held are measured at the lower of cost and net realisable value.

(f). Property, plant and equipment

Items of property, plant and equipment are measured at cost less accumulated depreciation and impairment losses. Cost includes expenditure that is directly attributable to the acquisition of the asset. Where an asset is acquired through a non-exchange transaction, its cost is measured at its fair value as at the date of acquisition.

Depreciation is charged on a straight line ("SL") or diminishing value ("DV") basis over the useful life of the asset. Depreciation is charged at rates calculated to allocate the cost or valuation of the asset less any estimated residual value over its remaining useful life:

- Building Improvements 17% (SL)
- Office Equipment 20% to 67% (SL)
- Vehicles 30% (DV)

Depreciation methods, useful lives and residual values are reviewed at each reporting date and are adjusted if there is a change in the expected pattern of consumption of the future economic benefits or service potential embodied in the asset.

(g). Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST except for receivables and payables, which are stated with the amount of GST included. The net amount of GST recoverable from, or payable to, the Inland Revenue Department is included as part of receivables or payables in the statement of financial position.

(h). Income Tax

Bowls NZ is wholly exempt from New Zealand income tax having fully complied with all statutory conditions as an amateur sports promoter under section CW 46 of the Income Tax Act 2007.

(i). Leases

Payments on operating lease agreements, where the lessor retains substantially all the risk and rewards of ownership of an asset, are recognised as an expense on a straight-line basis over the lease term.

Payments on finance lease agreements, where the lessee retains substantially the risk and rewards of ownership of an asset, are capitalised. The asset and the corresponding liability are recorded at inception at the fair value of the leased asset.

Interest charges under finance leases are apportioned over the terms of the respective leases.

Capitalised leased assets are depreciated over their expected useful lives in accordance with rates established for similar assets.

(j). Employee benefits

Wages, salaries, annual leave and sick leave

Liabilities for wages and salaries, annual leave and accumulating sick leave are recognised in surplus or deficit during the period in which the employee provided the related services. Liabilities for the associated benefits are measured at the amounts expected to be paid when the liabilities are settled.

(k). Significant accounting judgements, estimates and assumptions

The preparation of Bowls NZ's financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts of revenues, expenses, assets and liabilities, and the accompanying disclosures, and the disclosure of contingent liabilities. Uncertainty about these assumptions and estimates could result in outcomes that require a material adjustment to the carrying amount of assets or liabilities affected in future periods.

Judgements

In the process of applying Bowls NZ's accounting policies, management has made the following judgements, which have the most significant effect on the amounts recognised in the financial statements:

Operating lease commitments

Bowls NZ has entered into a number of operating leases.

Bowls NZ has determined, based on an evaluation of the terms and conditions of the arrangements, such as the lease term not constituting a substantial portion of the economic life of the property, that it does not retain all the significant risks and rewards of ownership of these properties and accounts for the contracts as operating leases.

Estimates and assumptions

There are no key assumptions concerning the future and other key sources of estimation uncertainty at the reporting date, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year.
